

Vague or undetermined link purpose (Level A)

Vacuous, meaningless link text like click here, click this, download, etc. tell users nothing about what the link points to.

For users who navigate with a keyboard or other assistive technologies, having to tab through such repetitive content on each page is laborious, time-consuming and considered an accessibility barrier.

Video begins playing automatically after page load (Level A)

Checks for automatically playing video. Any video that plays automatically upon page load causes a plethora of accessibility problems (in addition to annoying most non-disabled users). Any accompanying audio interferes with screen readers, making it difficult or impossible for blind users to find and stop playback. Users with mobility impairment must find and navigate to the video to stop playback. And users with cognitive impairment can become confused and unable to continue using the site.
