Mr. Humphries spent 11 years defending major insurance companies and its insureds. He was the lead trial lawyer at the firm having tried over 50 cases to jury verdict, including wrongful death, legal malpractice, breach of insurance contracts, trucking accidents, slip and fall, negligent security (shooting), and a variety of other types of cases. In 2013, Mr. Humphries was invited to join the prestigious Claims and Litigation Management Alliance (CLM), which is an invitation-only national organization created by the claims and litigation management industries.

Mr. Humphries was selected by his peers to join the American Board of Trial Advocates (ABOTA), a national association of experienced trial lawyers and judges dedicated to the preservation and promotion of the civil jury trial and elevating the standards of integrity, honor, ethics, civility, and courtesy in the legal profession.
