Ryan Christopher Rodems was born in Buffalo, New York, in December 1966 and moved to Lakeland, Florida, in 1973.

Mr. Rodems has been a member of the Florida Bar since 1992 and is admitted to practice in the U.S. District Court, Middle District and Southern District of Florida and the U.S. Court of Appeals, Eleventh Circuit. Mr. Rodems is also a member of the United States Supreme Court Bar.

Mr. Rodems graduated from the University of Florida with a Bachelor of Sciences degree in Business Administration, and from the Florida State University College of Law, where he was a member of the Florida State University Law Review from 1990-1992. In 1991, Mr. Rodems interned with the Florida Tenth Judicial Circuit State's Attorney's Office. In 1992, Mr. Rodems interned with then-Chief Justice Leander Shaw, of the Florida Supreme Court.

Mr. Rodems is Board Certified by the Florida Bar in Civil Trial law, and has extensive trial experience, representing clients in actions involving automobile accidents, injuries in retail and other public places, and in lawsuits arising under the Americans with Disabilities Act, the Family and Medical Leave Act, the Florida Civil Rights Act, ERISA, and has complex litigations and class actions.
