In April 2024, Ms. Molitoris obtained an \$11.9 million trucking verdict in Philadelphia County. In September 2023, she obtained a \$26.2 million trucking verdict in Philadelphia County which was one of the top 5 Pennsylvania Verdicts of 2023.

Ms. Molitoris' work was recognized in 2024 by the Legal Intelligencer when she won "Lawyers on the Fast Track." She has also been consistently recognized as a Rising Star by SuperLawyers and One To Watch by Best Lawyers.

In 2016, she received her Juris Doctor from the Thomas R. Kline School of Law at Drexel University. During law school, Ms. Molitoris was a member of the Student Bar Association, mock trial team, moot court team, and participated in the criminal law clinic.
