She represents severely injured people, or people who have lost a loved one as the result of medical malpractice, negligence, or recklessness. She has tried multiple cases to a jury in Tennessee, including being awarded a \$1.75 million verdict for the plaintiffs by a Rutherford County jury in a medical malpractice case.

Jenney has earned an AV Preeminent Martindale-Hubbell ranking, which is the highest ranking possible. She has been selected as a Super Lawyers Mid-South Rising Star (top 2.5% of attorneys in the mid-south) from 2015 through 2022. The National Trial Lawyers Association selected Jenney as one of the "Top 40 Under 40" lawyers in Tennessee in 2014, 2015, and 2016. She was also selected as one of Nashville's Top 30 Under 30 young professionals in 2012.

Jenney is a proud Fellow of the Nashville Bar Foundation and a member of the 2018 Tennessee Bar Association Leadership Law class. In addition, she is a member of the Nashville Bar Association and Tennessee Bar Association, where she has served on the boards of both organizations' Young Leadership Divisions.
