His successful career in jury trials and multiple eight figure verdicts earned Mr. Henratty the distinction of being named the Most Effective Personal Injury Lawyer in 2011 by ALM's Daily Business Review. Mr. Henratty has over 60 trials to verdict. He has obtained over 55 million dollars in verdicts and 100 million in settlements. He was inducted into the prestigious trial group of (ABOTA) in 2013, became Board Certified as a specialist in Civil trial law by the Florida Bar in 2017. That same year Mr. Henratty served as President of the Broward County Trial Lawyers association and continues as an Eagle member of the Florida Justice Association. Mr. Henratty is a member of The National Trial Lawyers which recognized him as one of the Top 100 Civil Plaintiff Lawyers in Florida.

A Florida native, Mr. Henratty graduated from the University of Florida and received his juris doctor from Mississippi College School of Law. He has attended trial colleges at the Stetson University and the University of Florida. Mr. Henratty is a founder and President of the Frankie Foundation, a Florida 501(c)(3) charitable organization, which provides Automated External Defibrillators (AED'S) to other charities and churches.
