Gregory J. Bosseler has achieved the highest level of recognition by the Florida Bar in the area of Civil Trial litigation.

Additionally, Mr. Bosseler previously served as a member of the Twentieth Judicial Circuit's Grievance Committee and was also a member of the prestigious Calusa Chapter of the American Inns of Court where he served as a Barrister. He is licensed to practice law in Georgia State Courts, Mississippi's State and Federal Courts, Florida's State and Federal Courts and Washington, D.C.

As a Board Certified Civil Trial Attorney, Mr. Bosseler has achieved the highest level of recognition by the Florida Bar in the area of Civil Trial litigation. Less than 2 percent of all the attorneys practicing in the State of Florida have earned this distinction.
