He annually is recognized by his peers as one of Atlanta's "SuperLawyers," and he was inducted into the Gate City Bar Association "Hall of Fame" in 2018. As a leader in the trial bar, Mr. Nix frequently teaches on the subject of trial advocacy, and bi-annually chairs a continuing legal education seminar on representing victims of traumatic brain injury, and coordinates the annual Excellence through Education seminar series for the Gate City Bar Association.
