Ms. Jeffcott's past multi-district litigation experience includes In re: Xarelto Products Liability Litigation, where she served as trial counsel in all bellwether trials, in addition to In re: National Prescription Opiate Litigation, In re: Zofran Products Liability Litigation, In re: FEMA Trailer Products Liability Litigation, and In re: Deepwater Horizon Oil Spill.

Ms. Jeffcott has also represented whistleblowers across the country. Prior to joining Morgan & Morgan, Ms. Jeffcott was lead counsel for Relators in a \$125 million qui tam settlement against Bechtel for alleged false claims related to the Hanford Nuclear Waste Treatment Plant in Washington. Ms. Jeffcott has also litigated cases involving Medicare fraud.
