Reflecting her heart for helping others, she earned the Dean's Distinguished Service Award and the Platinum Pro Bono Service Award from the Tennessee Supreme Court.

Following graduation and her admission to the Tennessee Bar and the United States District Court for the Middle District of Tennessee, Sarah entered private practice to stand up for individuals during some of the most challenging moments of their lives. In this early phase of her career, she developed a broad, client centered litigation foundation handling sensitive criminal defense, family law, and immigration matters. Navigating these deeply personal cases reinforced her empathy, sharpened her courtroom instincts, and deepened her dedication to giving everyday people a strong, compassionate voice within the legal system.
