His notable case results include a \$1,028,960 jury verdict in Philadelphia County (2025) in a pressure injury and wrongful death case; a \$2,975,000 arbitration award (2023) in a nursing home abuse case; and a \$1,000,000 jury verdict in Monroe County, PA (2017) involving a fall with hip fracture at a long-term care facility.

Jordan is licensed to practice law in both Pennsylvania and New Jersey. He is an active member of the American Bar Association, the Philadelphia Bar Association, and the Pennsylvania Association for Justice (PAJ), where he previously served as Co-Chair of the Nursing Home Division.
