The Morgan Story

John Morgan is known as the face of Morgan & Morgan. However, another Morgan — his brother, Tim — is why it all came to be.

Tim Morgan, a senior in high school, was working as a lifeguard at Disney World when he was asked to find a

girl who might be underwater. Tim accidentally dove into the not-visible concrete supports of a former dock. Sensing trouble, his supervisor dove in, but didn't immobilize Tim on a board before taking him out of the water. As a result, he suffered a severe injury to his spinal cord.

Tim filed a claim for workers' compensation and Disney World fought it. Instead of granting him a settlement, the company offered him a desk job during a graveyard shift. John Morgan, then 21, was so riled by the injustice that he decided to pursue a path in law.

Ever since Tim's accident, John's mission has been to fight for those who've been injured or taken advantage of — representing the "little guy" against large, negligent corporations. That includes taking on insurance companies that won't cover necessary medical costs, fighting against companies peddling dangerous products, challenging employers that skip out on overtime, and the list goes on.

We believe that no person should feel powerless, because we are on their side. So, when we at Morgan & Morgan say we are "for the people, not the powerful," we're continuing a legacy that began with family. In even the most trying and difficult times, we're here and committed to fighting for you.



Practice Areas

At Morgan & Morgan, we're here to fight for the people in many aspects of their lives. We wish they didn't need us, but the reality is they do and we're here for them 24/7. Below are highlights of just some of the practice areas in which we've been recovering for the people for more than three decades.

MOTOR VEHICLE ACCIDENTS

Motor vehicle crashes are a foundational practice area at Morgan & Morgan. Our attorneys have recovered millions dollars for clients whom insurance companies would otherwise have taken advantage of and shortchanged. We have a rep-

utation for turning low-ball pre-trial offers into million-dollar jury verdicts for victims of car, truck, motorcycle, boat, and other accidents.

Our lawyers have decades of experience helping injured drivers and passengers navigate every step of the post-accident process, providing a bulwark against the sometimes appalling machinations of large insurance companies. They are able to bring the full weight of the firm against those big corporations, securing economic and noneconomic damages for the sometimes life-changing harm suffered.

MEDICAL MALPRACTICE

People seek out our attorneys when the medical professionals they turn to for care provide them with treatment below the accepted standards of the medical community. This can include, but is not limited to, making the wrong diagnosis, administering the wrong drug, conducting the wrong surgery, and leaving surgical equipment in a patient's body during surgery.



Our medical malpractice attorneys make sure victims of medical negligence don't have insult added to their injury by bearing the costs that result from the negligent care they received.

BIRTH INJURIES

When a newborn suffers a birth injury because of a doctor's negligence, an entire family suffers from the physical and emotional consequences. The family could face a lifetime of bills for medical procedures, special schooling and services, and a variety of other needs that can create a severe financial strain. Their lives will never be the same.

Our lawyers have decades of experience handling every aspect of birth injury claims — seeing families through the difficult process of trying to get compensation that will help them cover all of their bills that stem from medical errors.

BURN & FIRE INJURIES

Some of the worst injuries out there — the ones that cause irreparable harm and change lives in unimaginable ways — are burn and fire injuries that hit apartment dwellers, homeowners, workers, patrons, and others who end up at risk because of another's negligence.

Our attorneys who handle burn and fire injury cases have a long history of winning compensation for victims of life-shattering accidents stemming from house fires, chemical fires, workplace accidents, electrical fires, and other types of burns. They draw

on decades of experience aggressively advocating for clients who've faced massive medical bills, permanently altered life situations, and profound pain and suffering.



WRONGFUL DEATH

Losing a loved one is devastating no matter the cause. But when the death is because of someone else's negligence, it adds a great weight to an already traumatic circumstance. Morgan & Morgan's attorneys help survivors pursue compensation to cover the considerable financial difficulties and pain and suffering, among other things, that may arise as a result of a loved one taken too soon.

Nothing can replace a lost loved one, but our attorneys can at least help survivors get the economic and non-economic damages they deserve.

PREMISES LIABILITY

When people enter venues open to the public, they have the right to expect they're entering a safe space. All too often, property owners are derelict in their duty to protect the people on their premises, which can have

serious consequences. Inadequate security can lead to everything from violent assaults, rapes, and mass shootings to robberies, falls, and other injuries.

While not all of those acts are preventable, many are if there is adequate security in place. When property owners fail to protect people on their property, our attorneys hold them accountable.

CONSTRUCTION ACCIDENTS

Construction workers are exposed to some of the most dangerous conditions of any workplace on a good day even when safety codes are followed. However, when a construction site is rife with safety violations, workers are left exposed to great risk while merely trying to make a living. Everything from structure collapses, falling objects, and fires to improper safety precautions and insufficient training, among other things, are dangerous realities construction workers can face.

Workers compensation claims, and the fight to get paid, are at the forefront of the aftermath of an injury.

However, construction accidents might also yield product liability and wrongful death claims, depending on the circumstances. Our construction accident attorneys have experience investigating liability for injury and pursuing claims on behalf of victims.

WORKERS' COMPENSATION

Workers' compensation is designed to help employees who are injured on the job get paid some income quickly — in exchange, they limit the liability to their employer and coworkers. This system doesn't always work as it should, though. Sometimes claims are unjustly denied or underpaid, and injured employees must appeal the decision and wait months to get that to which they are entitled.

Our workers' compensation attorneys help those facing compensation hurdles navigate the various steps in the often frustrating process of trying to get paid what they're owed. Without workers' compensation attorneys, the system would fail employees injured on the job far more often.

BREACH OF WARRANTY

If you purchase any product, from a CD player to a washing machine, a refrigerator to a jet ski, car, or RV, and it doesn't function properly, it falls under the purview of our Breach of Warranty department. The department's legal team has extensive experience with cases involving the 1975 Magnuson-Moss Warranty Act, which allows consumers of certain defective products to recover replacement costs and other compensation. They fight



for consumers for free, because the law requires the manufacturer to cover attorneys' fees.

BUSINESS LITIGATION

Business disputes are common, but not all businesses and individuals can afford the high hourly rates that traditional commercial law firms charge. Morgan & Morgan's Business Trial Group provides businesses with an affordable option for quality legal representation by working on a contingency-fee basis. Because we charge clients no upfront fees and no fees at all unless we successfully recover compensation for them, claims involving contracts, construction, real estate, securities fraud, intellectual property, and other disputes are decided solely on the merits.

CIVIL RIGHTS

We fight against the abuse of power, a core tenet for our civil rights group. All people have the right to be free

from excessive force, from unreasonable searches and seizures, and from cruel and unusual punishment.

Specifically, we represent victims of police brutality and wrongful imprisonment, including the victims of police shootings. Additionally, we represent prison inmates who have been physically and sexually abused or assaulted by staff. Other cases we handle involve the loved ones of prisoners who committed suicide in prison, and those injured or killed when their medical needs were neglected.

CLASS ACTIONS, MASS TORTS, & MASS ARBITRATION

Sometimes the only way that consumers, patients, and investors can hold large companies accountable is by banding together to file a lawsuit.

In certain cases this means filing a class action on behalf of a group of people who've all suffered a similar harm and injustice at the hands of a big company. In other instances, such

as with dangerous drugs or medical devices, several individual lawsuits called mass torts could be filed and are consolidated for pre-trial proceedings for more efficient justice. Our new mass arbitration team’s goal is to fight for the rights of a large number of individual plaintiffs barred from filing class actions or even going to court by contracts that require them to use private proceedings to get justice.

Our attorneys bring vast experience to bear in this area and have been at the vanguard of filing blockbuster class actions, such as the Facebook/Cambridge Analytica and Yahoo cases, and serving as leadership for plaintiffs in mass torts.

DEAF & DISABILITY RIGHTS UNIT

Unfair or discriminatory practices against people with disabilities can occur in a variety of ways, including the denial of interpreters, lack of structural accessibility, and denial of access to programs and services based on a person’s disability. Sharon Caserta leads this practice, which fights aggressively to get justice for people with disabilities who are denied their rights.

Although there are laws on the books, like the ADA and ADAAA, which protect people with disabilities, it takes devoted advocates to help ensure employers, businesses, governments, and other parties follow the law. Ms. Caserta and her team are committed to equality, justice, and accessibility for people who are blind, deaf, and hard of hearing, and those with all other types of disabilities.

FAIR CREDIT REPORTING ACT

Everyone is entitled to a fair credit report. The presence of erroneous, incomplete, and outdated information on those reports can cost people jobs and have a negative impact on their ability to get loans, credit cards, and insurance. If creditors refuse to remove it or are negligent, we will fight to recover compensation for any resulting losses. We’re experienced in handling credit report disputes, clearing credit report errors, and successfully recovering compensation for our clients.

LABOR & EMPLOYMENT

The Employment Rights Group helps employees who face wage theft, employer retaliation, denial of leave, workplace bias, harassment, and oth-

er issues that arise in the workplace. The group’s attorneys and support staff advocate for clients in cases involving a basket of federal, state, and local employment laws, including the Fair Labor Standards Act, the Civil Rights Act of 1964, and the Age Discrimination in Employment Act. The team has scored millions of dollars for clients, providing some measure of relief in the face of often difficult circumstances.

LIFE INSURANCE DISPUTES

The death of a family member is traumatic and painful. The last thing survivors need to worry about is a life insurance dispute. But if they do receive a claim denial, delay, or low-ball offer, our Insurance Recovery Group attorneys can help them fight for the compensation they might desperate-



ly need and get them some level of peace of mind. Our attorneys also handle AD&D and ERISA claims disputes.

LONG TERM DISABILITY

Many employers offer long-term disability policies to their employees for financial protection against injuries that leave employees out of work for long periods of time. Generally, families rely on this income to cover their needs, but they’re left with great

secondhand. It’s often seen in people who worked in the railroad, shipbuilding and other manufacturing industries, along with those who served in the military. Generally, some company or other organization knew that asbestos was dangerous, but regardless allowed its use in electrical wires, pipes and other equipment to which workers could be exposed.

Our attorneys help victims and their families get compensation for the ultimately fatal injustice they’ve faced



uncertainty and injustice when an insurer rejects the claim. Our Insurance Recovery Group attorneys fight on behalf of these families to pursue the income they need in order to achieve a sense of normalcy in their lives.

MESOTHELIOMA

Mesothelioma is a fatal cancer that victims get by being exposed to asbestos, either while on the job or

at the hands of negligent parties. The long latency period presents a significant challenge for our attorneys, who must identify when and where someone was exposed to asbestos, even though it likely happened decades ago. Despite this challenge, our attorneys have been able to help many mesothelioma victims and their families recover compensation for the injustice perpetrated against them long ago.

NURSING HOME ABUSE

When people entrust the care of their loved ones to a nursing home, they should expect good care from a knowledgeable staff in safe conditions. Unfortunately, some nursing homes value their bottom line over the quality of care they provide to their residents, which can lead to neglect and various forms of abuse by nursing home staff. This happens when facilities are understaffed, or hire people who are not qualified or are not properly trained to care for the elderly.

Our experienced nursing home abuse attorneys work to help the victims of abuse and neglect in nursing homes by trying to secure compensation for the pain and suffering they sustained at the hands of those who were supposed to care for them, all while holding the retirement facility accountable.

PRODUCT LIABILITY

People buy products with the expectation they’re safe and will work as advertised. Sometimes, however, consumers buy products that at best don’t do what they’re supposed to and at worst lead to injury or even death.

Our product liability lawyers handle cases when manufacturing defects, design defects, or improper warning labels lead to injury. If the defect in question is pervasive, and affects many consumers in a similar way, they are prepared to launch a mass tort to compensate the product’s victims and hold the negligent manufacturer accountable.

PROPERTY INSURANCE

Our Insurance Recovery Group helps homeowners and business owners who have received wrongfully denied property insurance claims, in addition to policyholders who have experienced the limbo of constant claims decision delays or low-ball offers.

These denials can have devastating financial effects on claimants whose homes are in need of repair, especially in the aftermath of hurricanes, tropical storms and other catastrophic events. Whether it's failing cast-iron pipes, wind and water damage, or major storms, our attorneys use their decades of experience to help those who have been shortchanged by their insurance companies.

SOCIAL SECURITY DISABILITY

For people who become disabled and can no longer work, Social Security

disability benefits can be an important source of income. However, the majority of people who apply for SSDI benefits are initially denied, which is often a disheartening and possibly frightening experience.

Our attorneys help those who need SSD benefits receive the compensation to which they're entitled. Additionally, they can help parents of disabled adult children receive benefits for the care of their child and help disabled widows and widowers receive benefits that can make their lives easier.

VETERANS' BENEFITS

Military veterans who put their lives on the line for our country are eligible for disability benefits if they sustained an injury during their service that lingers past their discharge. Sadly though, many veterans' disability claims are often denied initially,

which is unfair considering they were injured fighting for their country.

Our veterans' benefits attorneys help veterans navigate the application and appeals process so they can try to receive the disability benefits they deserve. In addition to disability, our attorneys help veterans and their families receive survivor benefits, vocational rehabilitation and employment benefits, educational benefits, life insurance, health care, home loans, and pension benefits.

WHISTLEBLOWER/QUI TAM

Billions of taxpayer dollars are lost to fraud every year, but there are laws in place that make it possible for brave whistleblowers to safely come forward and hold fraudulent contractors and other parties accountable. Many whistleblower lawsuits involve fraud against Medicare and Medicaid and defense agencies, but any government agency can be defrauded. Laws such as the False Claims Act allow private parties to file civil lawsuits over the fraud on behalf of the government and receive a portion of the funds the government recovers.

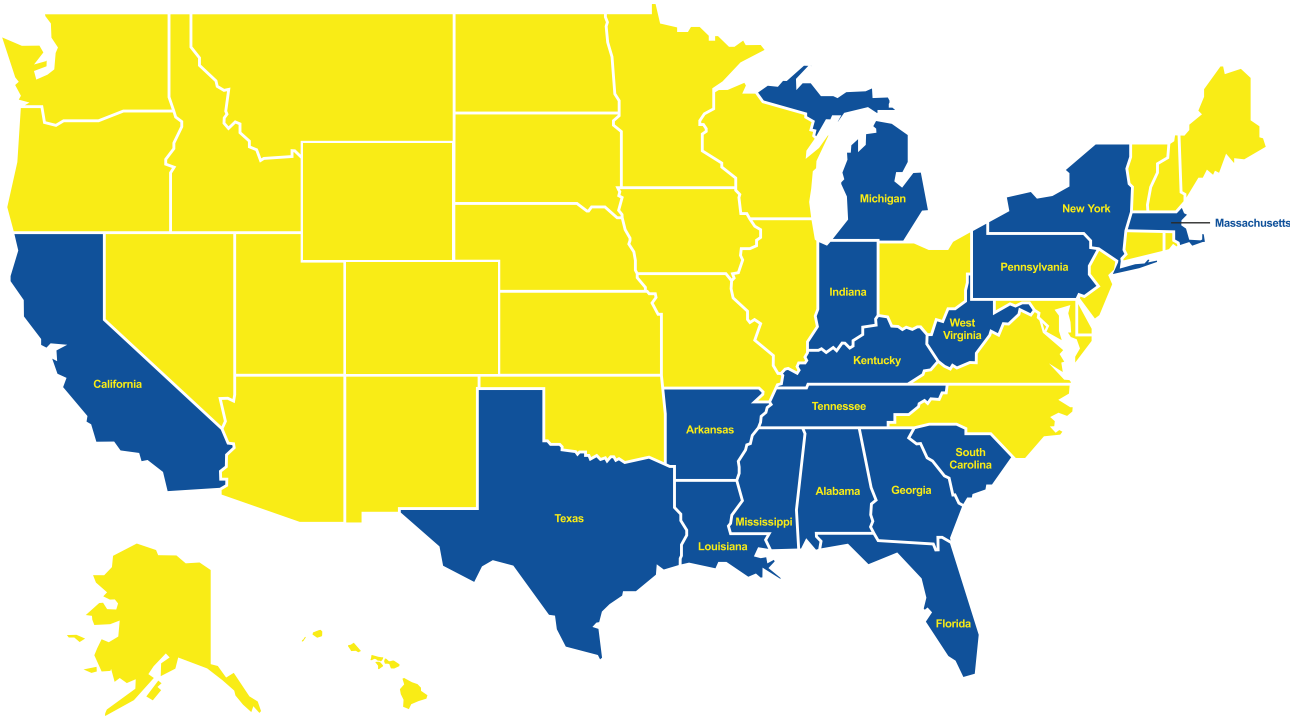

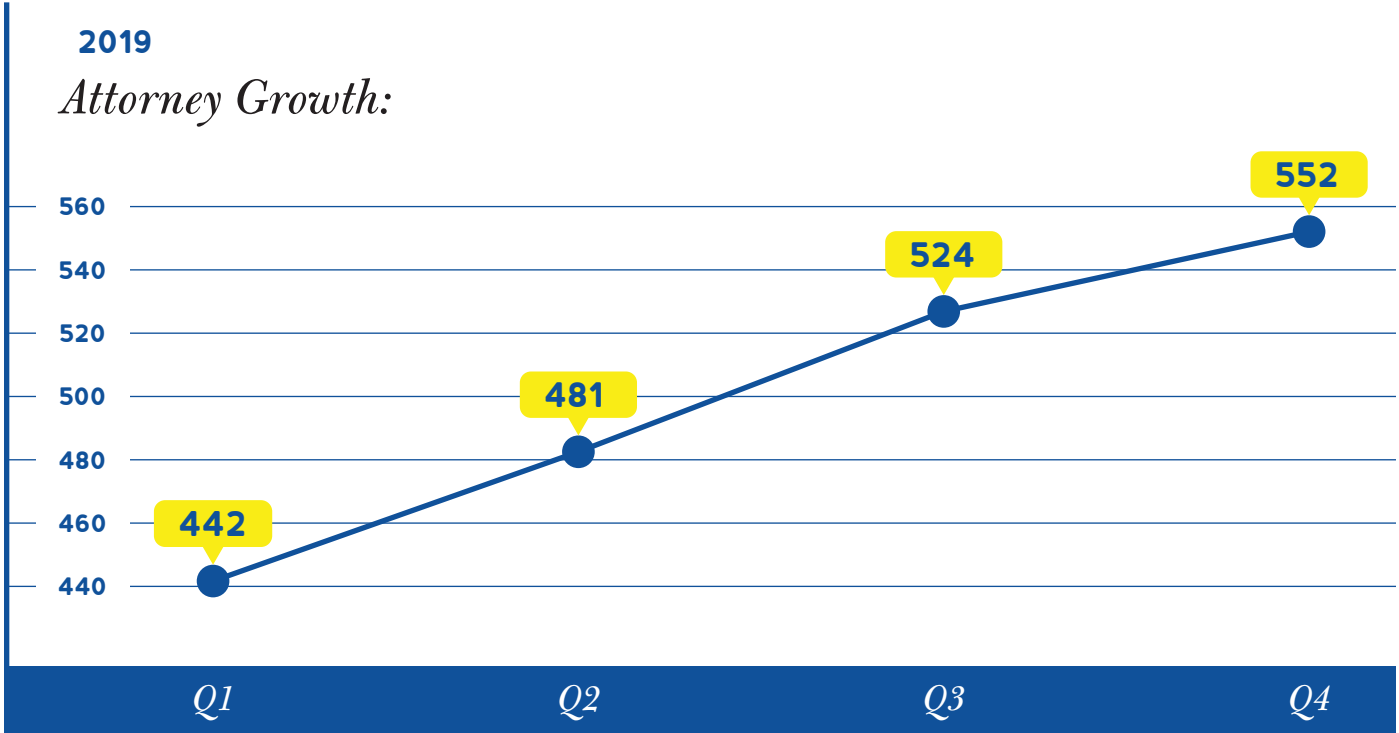

RESTORING BASKETBALL GLORY

In 2018, the NCAA imposed a penalty on the men’s basketball team at the University of Louisville (Kentucky) for alleged rules violations. They had their 2013 NCAA tournament win, 2012 Final Four appearance, and individual player statistics vacated and removed from the record.

With the help of John Morgan, our firm’s founder, the team’s players sued the NCAA and last year reached a confidential settlement. The players had all their statistical achievements and personal honors restored.

Last year, John achieved a notable victory when he and his team reached a \$117 million settlement with web giant Yahoo after a data breach compromised billions of user accounts.

MAJOR SETTLEMENT IN MA GAS EXPLOSIONS CASE

In September 2018, a series of explosions ripped through the Merrimack Valley, Massachusetts, towns of Lawrence, Andover, and North Andover. These explosions were caused by excess gas pressure in poorly built, poorly installed, and poorly maintained natural gas lines owned and operated by Columbia Gas of Massachusetts.

More than 40 homes experienced ex-

plosions and fires as a result, which caused severe damage and injury, including one death. Morgan & Morgan’s Frank Petosa took the lead in the lawsuit representing the victims, and in July 2019, a \$143 million settlement was reached.

Coverage appeared in The Washington Post and The Boston Globe, and was provided by the Associated Press.

FLORIDA POWERHOUSE

Although we’re a nationwide firm, Florida is still Morgan & Morgan’s home base. This year, the firm was recognized for its achievements in the Sunshine State as a Law360 “Florida Powerhouse.”

With over 350 attorneys in the state and more than two dozen offices,

FIGHTING FOR A ZIPLINE ACCIDENT VICTIM

A 10-year-old boy from Lakeland, Florida, was seriously injured when his zipline harness disconnected and he fell 20 feet to the concrete below. On behalf of his family, Morgan & Morgan is pursuing legal action against the operators of the zipline facility, alleging employee error due to improper training and safety procedures.
