WHAT DAMAGES CAN BE RECOVERED?

- Medical expenses: Hospital stays, prescription medication, ongoing treatments

- **Punitive damages:** In cases where the offender can be punished to discourage this type of harmful action

Types of Personal Injury Cases

Motor Vehicle Accidents (Car, Motorcycle, Truck)

Motor vehicle crashes can cause devastating injuries with lifelong consequences. Victims of motor vehicle accidents who can prove negligence may be entitled to compensation for damages like present and future medical bills, lost wages, emotional anguish, and pain and suffering.

Bicycle/Pedestrian Traffic Accidents

Traffic accidents are even worse when one of the victims was either walking or riding a bicycle. Bicycle and pedestrian accident victims have far less physical protection and often end up suffering more severe injuries. A lawsuit can provide compensation for damages such as medical bills and lost wages.

Slip & Fall

Preventable falls can be the source of very serious injuries, especially for those 65 and older. Property owners are obligated to keep their premises safe and could be held liable for medical bills, pain and suffering, and missed work if someone slips and falls due to negligent upkeep.

Medical Malpractice

People trust doctors with their lives, so it's especially traumatic when negligent care puts their health at risk. Doctors, nurses, and other medical personnel are legally obligated to do their best to protect their patients. If they fail to meet a reasonable standard of care, healthcare employees

could be liable for medical bills, lost wages, pain and suffering, and wrongful death.

Defective Products

Manufacturers are legally obligated to make products that are safe when used as directed. If a defective product causes injury, the manufacturer can be held liable for damages. Workplace Accident

Workers' compensation insurance is meant to protect employees injured on the job; however, employers and insurance companies often try to save money by underpaying or denying claims. In these cases, a lawsuit can be filed to recover benefits such as medical treatment, physical

> therapy, medication, and compensation for missed work.

Birth Injury

Injuries during birth are heartbreaking for parents and can cause lifelong, debilitating health conditions for newborns. Tragically, some birth injuries are the result of medical malpractice, leaving parents with overwhelming medical bills. Victims may be eligible to

Dog Bite

Burn Injury

Fire and burn injuries can be profoundly painful and life-altering experiences. Sometimes these injuries are the result of negligence, such as when workplaces, apartments, or public spaces are not kept up to fire codes. Burn injury victims may be eligible for damages that can help pay

medical bills, cover lost work, and compensate for pain and suffering.

Mesothelioma

Those who were exposed to asbestos run the risk of developing mesothelioma, a rare but very dangerous type of cancer. More than 2,000 Americans are diagnosed with mesothelioma every year from settings such as construction sites, manufacturing plants, and mines. Even some talcum powder has been shown to contain asbestos. Mesothelioma victims can recover damages including lost wages, pain and suffering, and medical expenses.

Dangerous Drugs

Prescription and over-the-counter drugs help keep us healthy, but some drugs have dangerous side effects and unintended consequences. Ineffective testing, poor manufacturing, and inappropriate prescriptions can all contribute to serious health problems. If you've been harmed by a drug, a lawsuit could help you win compensation for any damage it has caused.

Nursing Home Abuse

Elders are among our most beloved citizens, but they also can be vulnerable to abuse and exploitation. If a loved one in a nursing home shows warning signs such as bed sores, poor hygiene, or sudden changes in weight, these may be symptoms of abuse. An attorney can investigate and seek financial compensation if nursing home abuse is discovered.





In the News

Here are some of our cases that made headlines in 2019.



Restoring Basketball Glory

In 2018, the NCAA imposed a penalty on the men's basketball team at the University of Louisville (Kentucky) for alleged rules violations. They had their 2013 NCAA tournament win, 2012 Final Four appearance, and individual player statistics vacated and removed from the record.

With the help of John Morgan, our firm's founder, the team's players sued the NCAA and last year reached a confidential settlement. The players had all their statistical achievements and personal honors restored. Coverage appeared on ESPN, Fox Sports, and in the Associated Press, among others.

Morgan & Morgan Attorney Named Cybersecurity MVP

Morgan & Morgan's John Yanchunis was named a 2019 MVP by Law360 — the premier national legal news service — in recognition of his work protecting the rights of consumers harmed by data breaches.

Last year, John achieved a notable victory when he and his team reached a \$117 million settlement with web giant Yahoo after a data breach compromised billions of user accounts.

Major Settlement in MA Gas Explosions Case

In September 2018, a series of explosions ripped through the Merrimack Valley, Massachusetts, towns of Lawrence, Andover, and North Andover. These explosions were caused by excess gas pressure in poorly built, poorly installed, and poorly maintained natural gas lines owned and operated by Columbia Gas of Massachusetts. More than 40 homes experienced explosions and fires as a result, which caused severe damage and injury, including one death. Morgan & Morgan's Frank Petosa took the lead in the lawsuit representing the victims, and in July 2019, a \$143 million settlement was reached.

Coverage appeared in The Washington Post and The Boston Globe, and was provided by the Associated Press.

Florida Powerhouse

Although we're a nationwide firm, Florida is still Morgan & Morgan's home base. This year, the firm was recognized for its achievements in the Sunshine State as a Law360 "Florida Powerhouse." Fighting for a Zipline Accident Victim

A 10-year-old boy from Lakeland, Florida, was seriously injured when his zipline harness disconnected and he fell 20 feet to the concrete below. On behalf of his family, Morgan & Morgan is pursuing legal action against the operators of the zipline facility, alleging employee error due to improper training and safety procedures.
